Pursuant to Section 607.1403 of the Florida Statutes, the undersigned Corporation adopts these Articles of Dissolution.



FIRST: The name of the Corporation is SLIDE SEAL, INC.

SECOND: The dissolution was authorized on December 31, 1998.


THIRD: The dissolution was approved by the Shareholders. The number of votes cast in favor of the dissolution was 100, which was sufficient for approval pursuant to law.


