ARTICLES OF INCORPORATION OF L AND L PROPERTIES, INC.

The undersigned, acting as the incorporators of L AND L PROPERTIES, INC. under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION: The name of the Corporation is L AND PROPERTIES, INC.
