THE UNDERSIGNED HEREBY MAKES, SUBSCRIBES, ACKNOWLEDGES AND FILES THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I

THE NAME OF THIS CORPORATION SHALL BE APPEARANCE CORPORATION

ARTICLEJI

THE STREET ADDRESS IN THIS STATE OF THE PRINCIPAL OFFICE OF THIS CORPORATION SHALL BE: 1701 N.E. 63RD COURT FT. LAUDERDALE, FL. 33334

ARTICLE III

THE CORPORATION SHALL HAVE PERPETUAL EXISTENCE, COMMENCING WITH THE DATE OF FILING OF THESE ARTICLES.
