To Whom It May Concern:

This letter is in response to the attached copies of the *Notice of Intent to Dissolve* for the above mentioned taxpayers. The taxpayers all have the same resident agent, Allan Nalli. It is the intention of all of the above mentioned taxpayers that they continue as Florida corporations. The late filing of the 2004 Annual Reports was inadvertent and the result of unusual circumstances.

The resident agent and his wife (who is also the business manager for all three taxpayers) have spent much of 2004 in Michigan where the wife has been receiving treatment for a serious illness. Their Florida mail was supposed to be forwarded to them in Michigan. However, there were problems with the mail service and several items of mail were lost. We believe that the 2004 Annual Reports for the above mentioned taxpayers were among those lost items. Because of the seriousness of his wife's illness, neither Mr. Nalli nor Mrs. Nalli thought about the annual reports. It was the taxpayers' intention to comply with Florida's filing requirements as they always have in the past.

Please find enclosed with this letter the 3 annual reports and 3 checks. One from each of the above mentioned taxpayers for the original filing fee of \$150.00. We respectfully request that due to the taxpayers' unusual circumstances the State of Florida would accept the \$150.00 as payment in full for the 2004 Annual report and not assess the \$400 late filing fee.
