We, the undersigned, hereby associate together for the purpose of becoming a corporation under the laws of Florida, by and under the provisions of the statutes of the State of Florida and immunities of corporation profits.

ARTICLE I

The name of this corporation shall be : SHATAT INC.

Its business shall be carried on at Dade County, Florida, and at such other points or places in the state of Florida and in the United States and foreign countries as may from time to time be authorized by the Board of Directors. Its principle office shall be at: 2549-2557 Park Lane.

ARTICLE II

The general nature of the business or businesses to be transacted are, follows: Wholesale, Retail, Export & Import & Other related matters.

SECTION II.

That of purchasing, leasing, renting, selling, holding and otherwise acquiring and disposing of real estate and personal property, both tangible and intangible, and chooses in action either as owner, agent or factor.

SECTION III


