ARTICLES OF INCORPORATION

OF

J.D.L. AUTO, INC. A NEW FLORIDA CORPORATION

The undersigned subscribers to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

ARTICLE I
