ARTICLES OF INCORPORATION

OF

NICELY DONE, INC.

I, the undersigned natural person of the age of twenty-one years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by the virtue of the laws of the State of Florida;

I.

The name of the corporation is Nicely Done, Inc. whose principal office is located at 3818 County Line Road, Apt # 140, Tequesta, Palm Beach County, Florida 33469.

The period of duration of the corporation is perpetual.

The corporation shall have the authority to issue 5,000 (five thousand) shares of common stock with a par value of \$ 1.00 per share.


