

ARTICLES OF INCORPORATION  
OF  
DIANE CHRISTIE BACCUS HORSLEY, P.A.

THE UNDERSIGNED subscriber of these Articles of Incorporation, a natural person, competent to contract, form a professional service corporation under the laws of the State of Florida, and further agree to the following conditions of said professional service corporation:

## ARTICLE I

The name of the professional service corporation is Diane Christie Baccus Horsley, P.A.

## ARTICLE II

The address of the principal office of the corporation shall be Suite C, 25 West New Haven Avenue, Melbourne, Florida 32901.

## ARTICLE III

The purpose and specific nature of the business of the corporation shall be the rendering of professional legal services and for the transaction of any or all lawful business.

## ARTICLE IV

The corporation is authorized to issue ONE HUNDRED (100) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.

## ARTICLE V

Except as otherwise provided by law, the entire voting power for the election of Directors and for all other purposes shall be vested exclusively in the holder of the outstanding common shares.

## ARTICLE VI

The officers shall be elected at the annual meeting of the Board of Directors, or as provided by the By-Laws.


#### ARTICLE X
