ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is SCRAP-ALL BROKERAGE, INC., and the principal address is 2801 4th Avenue, Tampa, FL 33675.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is Mason & Associates, P.A., 17757 U.S. Hwy. 19 North, Suite 500, in the City of Clearwater, County of Pinellas, Florida 34624. The name of its registered agent at such address is Joseph C. Mason, Jr.

ARTICLE III - PURPOSE
