ARTICLES OF INCORPORATION

ARTICLE I - Name

The name of this corporation is Gilbert A. Contreras, P.A.

ARTICLE II - Principal Office

The mailing address of this corporation shall be: 2903 Salzedo Street

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting and operating a law office pursuant to the Rules of the Florida Bar and the laws of the State of Florida.

The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


ARTICLE X - Amendment
