

ARTICLES OF INCORPORATION
OF
S.C.I. MARCO PARIS INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of this corporation is S.C.I. MARCO PARIS INC.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSES

The purpose for which the corporation is organized is:
To engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE FOUR
CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is one hundred (100), all of which shall be common shares without par value. The consideration for the issuance of shares may be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation.

REGISTERED OFFICE


