I received from one of my associates a "Notice of Administrative Dissolution or Revocation" that had been forwarded to his home in the mail. If I could take a few minutes to explain my situation for your better understanding of why this comes as a total surprise to me in hopes that we can easily and inexpensively correct this problem.

Our corporation has been run for the past few years directly by the board of directors. Just this past June there was a major reorganization of our company, during this time our operations were shut down, offices closed up, among other things our PO Box cancelled and the acting board resigned. As a result of this, a new board was appointed by the stock holders. In this appointment I was privileged enough to become the new and acting Secretary/Treasurer. I can assure it has been an adventure, as each month comes and goes I learn what responsibilities the prior board neglected to take care of, this being one of them. To put it bluntly, everything was just dropped in my lap and the surprises just keep popping up. I pray that this is the last.

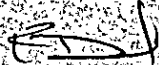
With the closing of our office and cancellation of our PO Box, among other things, I never received the 2001 Uniform Business Report that I am positive your office sent to us. This Notice of Administrative Dissolution or Revocation is the first Florida Corporation Filing paperwork that I have seen, this is only because it was forwarded to our only remaining original board of director at his home address.

I have included with this letter the filled out Application for Reinstatement, 2001 UBR with new and current officers and mailing addresses and a check for \$155 to cover our annual corporation fees.

I thank you in advance for your help in my hopes to remedy this situation as quickly and inexpensively as possible. I am hoping that the included information will satisfy our corporation's responsibilities with the state of Florida.
