CERTIFICATE OF INCORPORATION

FIRST. The name of this Corporation is: KIPPER CORP.

SECOND. Its principal/registered office in the State of Florida is to be located at 343 HAZELWOOD AVE. S., LEHIGH ACREA, FL 33936, County of Lee. The registered agent in charge thereof is Michael Lynn Keelan.

THIRD. The nature of the business and, the objects and purposes proposed to be transacted, promoted and carried on, are to engage in any lawful act or activity for which corporations may be organized under the Laws of Florida.

FOURTH. The amount of total authorized capital stock of the corporation is to be FIVE THOUSAND shares of TEN CENTS (\$0.10) par value.

EIGHTH. All of the issued stock of all classes shall be subject to the following restriction on transfer permitted by Law:

Each stockholder shall offer to the Corporation or to the other stockholders of the Corporation a thirty (30) day "first refusal" option to purchase his/her stock should he/she elect to sell said stock.
