of

ARTICLE I - NAME

The name of the corporation is A TEL SECURITY OF WEST CENTRAL FLORIDA, INC. and whose principal office location is 3672 IMPERIAL RIDGE PARKWAY PALM HARBOR, FL 34684

This corporation shall exist perpetually.
