THE STATE OF Florida COUNTY OF Escambia

That the undersigned, natural person(s) of the age of at least aighteen (18) years, acting as Incorporator(s) of a Corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation for such Corporation, to wit:
