ARTICLES OF INCORPORATION

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the corporation is

Administrative Consulting Services, Inc

ARTICLE TWO

The principle office of the corporation will be located at 801 W. Leeland Heights Blvd, Lehigh Acres, Fl 33936 or such other place or places at maybe designated by the Board of Directors at some future date.

ARTICLE THREE

The duration of the corporation is perpetual, except that same may be dissolved, as provided by law and pursuant to Section 607 of the Statutes of the State of Florida.

ARTICLE FOUR

The general purposes for which the corporation is organized are:

1. To transact business within and outside the State of Florida, to contract to buy and sell real estate, personal property, and any other commodity of a legal nature that can be bought and sold.
2. To transact any other lawful business for which a corporation may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business and
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FIVE

The amount of total authorized Capital Stock of the corporation shall be 2,000 shares of stock, with par value of One Dollar & 00/100 each. Stock being fully paid and non-assessable.

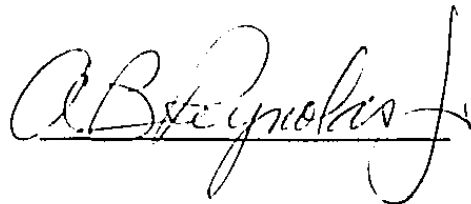
