ARTICLES OF INCORPORATION

OF

I, the undersigned natural person of the age of twenty-one years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by the virtue of the laws of the State of Florida;

I.

The name of the corporation is Michael G. Bairey, D.C., P.A. whose principal office is located at 4760 West Atlantic Avenue, Delray Beach, Palm Beach County, Florida 33445.

II.

The period of duration of the corporation is perpetual.

III.

The purposes for which the corporation is organized are; the practice of chiropractic medicine and massage therapy in accordance with State of Florida regulations regarding such practices; and any other act or activities for which corporations may be organized under the General Statutes of the State of Florida.
