# PROPOSALS BY DESIGN, INC.

TALLAMASSES PLONISS The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

#### ARTICLE I: NAME OF THE CORPORATION

The name of the corporation is PROPOSAL BY DESIGN, INC., hereinafter referred to as the "Corporation".

#### ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS
