We, the undersigned, for the purpose of incorporation under the laws of the State of Florida, provide for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I

NAME

The name of this corporation shall be: AIR COMM COMMUNICATION SERVICES, INC.

ARTICLE II

GENERAL NATURE OF BUSINESS

The general nature of business and the objects and purposes proposed to be transacted by this corporation is any activity or business permitted under the laws of the State of Florida, and the laws of the United States of America.

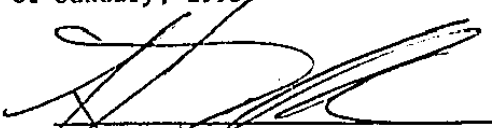

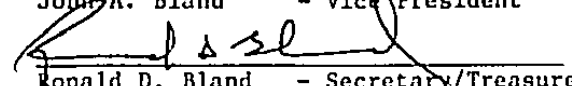

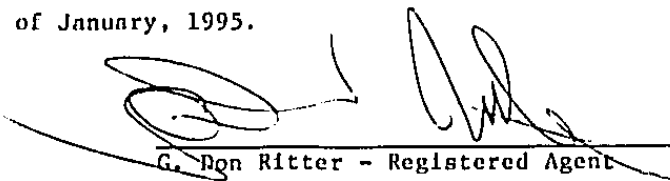
