OF

ARTICLE I. - NAME

The name of this corporation is COMPUSTAT INC.

ARTICLE II - PRINCIPAL OFFICE



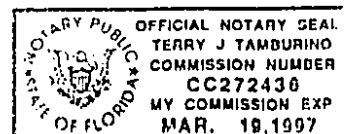


