

ARTICLES OF INCORPORATION OF TAN INTERNATIONAL CARGO, INC.



The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I -NAME

The name of the corporation is TAN INTERNATIONAL CARGO, INC.
