FOR


## **ARTICLE X INDEMNIFICATION**

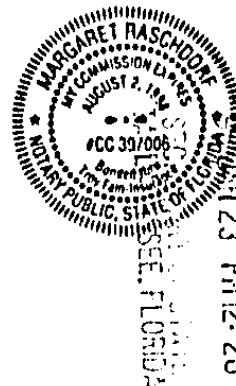
