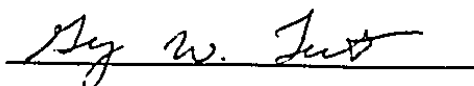

ARTICLES OF INCORPORATION

OF

ARTICLE ONE- CORPORATE NAME

ARTICLE TWO- DURATION

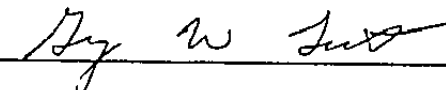
