The undersigned does hereby subscribe to, acknowledge and file the following Articles of IALLAHASSEE, FLORIDA Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## ARTICLE I - NAME

The name of this corporation is PALM BEACH INVESTMENT GROUP, INC.

### ARTICLE II - PURPOSE

This corporation in organized for the purpose of transacting any and all lawful business permitted under the laws of Florida.
