ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is MOBILE AUTO LUBE, INC., and its principal office or mailing address is 4707 - 140th Avenue North, #215, Clearwater, FL 34622.

ARTICLE 2: DURATION

This Corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE 9: BYLAWS
