ARTICLES OF INCORPORATION
ATLANTIC SERVICES INTERNATIONAL, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation.

ARTICLE I

NAME

The name of the corporation is Atlantic Services International, Inc.

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act.

ARTICLE IV

CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is 1000 of which shall be common shares.

ARTICLE V

Preemptive Rights. Each Share holder of the Corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the price for which it is offered to others , that Shareholders pro rata portion of the following:

a) any stock of any class that the Corporation may issue or sell, whether or not exchangeable for any stock of the Corporation of any classes, and whether or not of unissued shares authorized by the Articles of Incorporation as originally filed or by any amendment thereof or out of shares of stock of the Corporation acquired by it after the issuance thereof, and whether issued for cash or other consideration; or

b) any obligation that the Corporation may issue or sale which is attached or pertinent any warrant or warrants or other instruments conferring on the holder the right to subscribe for or purchase from the Corporation any shares of its stock of any class or classes.

This right shall be deemed waived by any Shareholder who does not exercise it and pay for the shares preempted within thirty (30) days after receipt of written notice from the Corporation stating the price, terms, and conditions of the issue of shares and inviting the Shareholder to exercise this preemptive right. This right may also be waived by a written waiver signed by the Shareholder.

ARTICLE VI

REGISTERED OFFICE

The street address of the initial office/principal office of the corporation is 241 Circle Drive, Maitland, Florida 32751, and the name of the initial registered agent at such address is Dan Stevens.

ARTICLE VII

Bylaws. The power to adopt, alter amend, and repeal the Bylaws shall be vested in the Board of Directors, but all alterations, amendments, and repeals of the bylaws must be by a unanimous vote of all Shareholders.

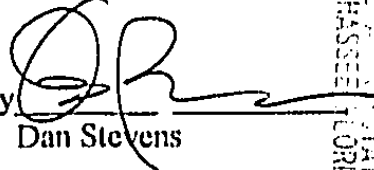
