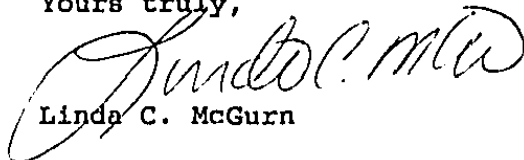

OF

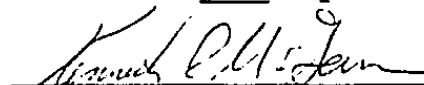

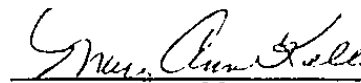

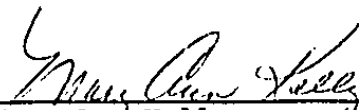
