ARTICLE ONE

The name of the corporation is: CLARK CUSTOM HOMES, INC.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida Corporation Act, with specific business in the design and construction of residential homes.
