

ARTICLES OF INCORPORATION  
OF  
J.A.M. SERVICES, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I  
NAME

The name of the Corporation is J.A.M. SERVICES, INC.

ARTICLE II  
DURATION

This corporation shall have perpetual existence.

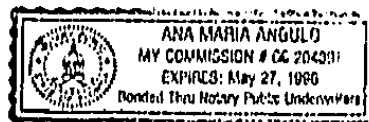
