ARTICLES OF INCORPORATION

OP

Best Tile & Marble, Inc.



THE UNDERSIGNED SUBSCRIBER, acting as Incorporator of a corporation (hereinafter referred to as the 'CORPORATION'), under the provisions of the Statutes of the State of Florida, does hereby make, subscribe, acknowledge and file the following Articles of Incorporation.

ARTICLE 1:

1.1) Name: The name of the Corporation is:

Best Tile & Marble, Inc.

ARTICLE 2:

2.1) <u>Purposes</u>: The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE 3:

- 3.1) <u>Number of Authorized Shares</u>: The aggregate number of capital stock which the Corporation shall have authority to issue is One Thousand (1,000) of Common Stock of a par value of One Dollar (\$1.00) per share.
