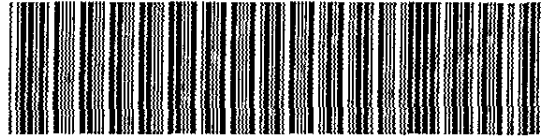



## ARTICLES OF AMENDMENT
