AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF LLAHASSEE. FLORIDA WILDCARD SYSTEMS, INC.

- 1. They are the duly elected and acting President and Chief Financial Officer of WildCard Systems, Inc., a Florida corporation.
- 2. The Amended and Restated Articles of Incorporation of this corporation are hereby amended by:
 - (i) adding a new sentence at the end of Article IV Section L.3.(a) as follows;

"In the event that the Company executes an agreement to consummate an Acquisition or Asset Transfer on or prior to June 15, 2005, and in the event that such transaction is consummated on or prior to September 15, 2005, then notwithstanding any provision herein to the contrary, the Primary Series E Liquidation Payment shall be equal to \$10.00 per share of Series E Preferred."

(iii) adding after the words "at any time" in the first sentence of Article IV Section L.4.(a) the following:

"(including after the payment to the holder thereof of the Primary Series E Liquidation Payment but before the Secondary Series E Liquidation Payment)"

3. This Amendment to Amended and Restated Articles of Incorporation has been duly approved by the Board of Directors of this Corporation.
