**ARTICLE I - Name and Principal Office**

The name of this corporation is **PROGRESSIVE INFUSION, INC.** The principal office of this corporation is: 11100 - 66th Street North, Suite 22, Largo, FL 34643.

**ARTICLE II - Duration**

This corporation shall have perpetual existence.

**ARTICLE III - Purpose**

This corporation is organized to include the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as presently enacted and as it may be amended from time to time.

**ARTICLE IV - Capital Stock**

This corporation shall be authorized to issue One Thousand (1,000) shares of common stock at \$.01 par value per share.

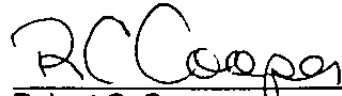
ARTICLE VIII - Indemnification
