INITIAL BOARD OF DIRECTORS

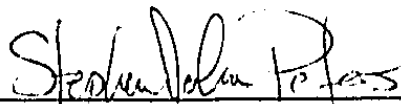

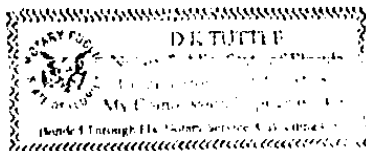
