ARTICLES OF INCORPORATION
OF
BLUE VELVET DINER, INC

I, the undersigned natural person, competent to contract, acting as incorporator of a corporation under the General Corporation Law of the State of Florida, make, subscribe, acknowledge and file the following Articles of Incorporation for such corporation.

ARTICLE I - NAME

The name of the corporation is:

BLUE VELVET DINER, INC

ARTICLE II - GENERAL NATURE OF BUSINESS

The general nature of business to be transacted is:

To operate a restaurant, and to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK

The amount of authorized capital stock is One Thousand Dollars (\$1,000.00) consisting of one thousand shares (1,000) of common stock, having a par value of One Dollar (\$1.00 per share).

ARTICLE IV - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of any kind, class or series, shall have the pre-emptive right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

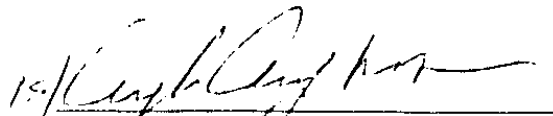
