ARTICLES OF INCORPORATION CARIBBEAN K LINE INC.

A STATE OF THE PARTY OF THE PAR The undersigned hereby adopts the following Articles of Incorporation for purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I - Name

The name of the corporation is CARIBBEAN K LINE INC.

ARTICLE II - Commencement of Existence and Duration

This corporation is to commence its corporate existence on the date of the filing of these Articles of Incorporation pursuant to Fla. Stat. §607.167 and shall exist perpetually thereafter until dissolved sooner according to law.
