We, the undersigned, do hereby associate ourselves for the purposo of becoming a corporation under the Laws of the State of Florida, and under the Statues of the State of Florida providing for the formation, rights, privileges, immunities and liabilities of incorporating for profit, and do hereby declare:

ARTICLE ONE

The name of the corporation shall be: ELKA TRAVEL, INC.

ARTICLE TWO

The corporation may, and shall, engage in any activity or business permitted under the Laws of the State of Florida and of these United States of America.

ARTICLE THREE

The maximum number of shares which this corporation is authorized to issue and have outstanding at any one time shall be Five Hundred shares of common stock. Said common stock shall have a par value of One (\$1.00) Dollar per share.
