Article I

Name

The name of the corporation is Pat-Curr Enterprises, Inc.

Article II

Duration

This corporation shall exist perpetually.

Article III

Nature of Business

This corporation is organized for the purposes of transacting any or all lawful business.

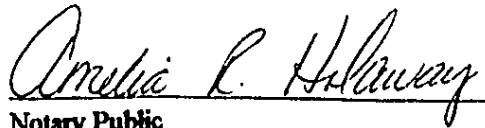

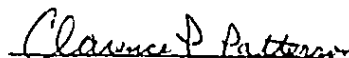
