ARTICLES OF INCORPORATION
OF

The undersigned Incorporator subscribing to these Articles of Incorporation, being competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be: S.L.C. GROUP, INC., and its initial mailing address shall be Post Office Box 20553, Bradenton, Florida 34203. The initial address of the Corporation's principal office shall be 11911 Upper Manatee River Road, Bradenton, Florida 34202.

ARTICLE II

The purpose of this Corporation is to engage in any and all business not prohibited by the Laws of the State of Florida.

This Corporation shall have all powers given corporations under the Laws of the State of Florida.

ARTICLE III

ARTICLE VII

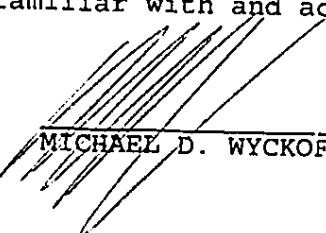
These Articles of Incorporation may be amended in the manner provided by law.
