forms a corporation under the laws of the State of Florida as

follows:

ARTICLE I.

Name

The name of this corporation is SOUTHEAST SALES FORCE, INC.

The mailing address of the corporation is 1520 Northwest 101st

Avenue, Plantation, Florida 33322.

ARTICLE II.

Term of Existence

The date when corporate existence shall commence shall be the date of filing of these articles with the Department of State, and the corporation shall have perpetual existence thereafter.

ARTICLE III.

Nature of Business

- (h) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
