ARTICLES OF AMENDMENT ARTICLES OF INCORPORATION OF P.C. SOLUTIONS, INC.

SAMO PALOS

Pursuant to the provisions of section 607,1006 Florida Statutes, this Florida corporation adopts the following articles of amendment to its articles of incorporation:

FIRST:

Article I is amended to read as follows:

The name of the corporation is Network Technologies Group, Inc.

SECOND:

Article TV... relating to the authorization of shares is deleted in its entirety and

in its place is added the following:

Article <u>IV</u> - Classes of Stock Voting and Nonvoting

- 1. Total Shares - The aggregate number of shares the corporation has authority to issue are ten million shares (10,000,000), being no more than five million (5,000,000) of Class A stock and five million (5,000,000) of Class B stock, as defined below.
- Classes and Rights The shares of the corporation are divided into two classes of stocks 2. - Class A and Class B. The two classes are identical in rights and powers except that the holders of Class B stock shall have no voting power for any purpose. All voting power is listed exclusively in the holders of Class A stock.
- 3. Par-Value - Poth Class A and Class B stock shall be issued with no par value.

There are currently 111 issued and outstanding shares. Existing shareholders will receive 16,529 shares of new Class A shares for each share of old stock held.
