ARTICLES OF INCORPORATION
FOR
CHELSEA MORNING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation is **CHELSEA MORNING, INC.** The principal address is:

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

Purpose

The general purposes for which the corporation is organized are the following:

- B. To do such other things as are incidental to the purposes

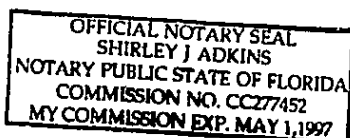
