ARTICLE I.

The name of this corporation is: **AXIS: ORLANDO COMMUNICATIONS, INC.**

ARTICLE II.

This corporation is organized for the purpose of transacting wholesale and retail sales and any or all lawful business permitted under the Laws of the United States and of the State of Florida.

ARTICLE III.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Seventy Five Hundred (7500) shares capital stock having a par value of One Dollar (\$1.00) each.

This corporation shall have perpetual existence.



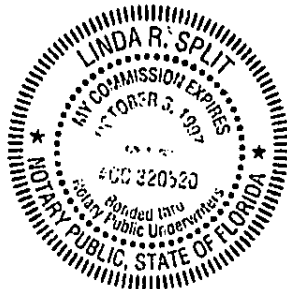
