ARTICLE ONE

The name of the corporation is GENE'S VENDING SERVICE, INC.

ARTICLE TWO

CORPORATION DURATION

The duration of the corporation is perpetual.

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

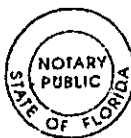

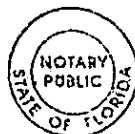
