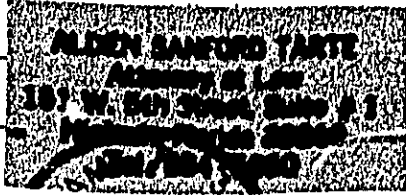

The undersigned, a natural person, of the age of twenty-one years or more, acting as incorporator of the corporation, under the Florida Business Act, adopts the following Articles of Incorporation of such corporation.

ARTICLE I

The name of the corporation is WORLD RESOURCES CAFE, INC.

ARTICLE II

The period of its duration is perpetual existence pursuant to the laws of the State of Florida.

ARTICLE III

The purpose or purposes for which the corporation is organized are: to engage in any and all business activities or business enterprises permitted under the laws of the United States and the laws of the State of Florida; to purchase, sell or hold any or all property both real and personal; to engage in any lawful business activity, both foreign and domestic.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is - 100 - shares of common stock at a par value of \$5.00 per share.

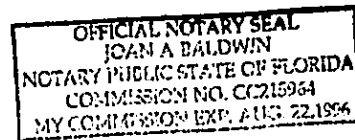
