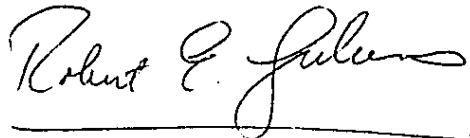

ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation is:

ARTICLE II

The duration of the corporation shall be perpetual, and the date and time of commencement of corporate existence shall be February 1, 1995.

ARTICLE III

The general purpose for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is seven thousand five hundred (7,500) having par value of \$1.00 per share.
