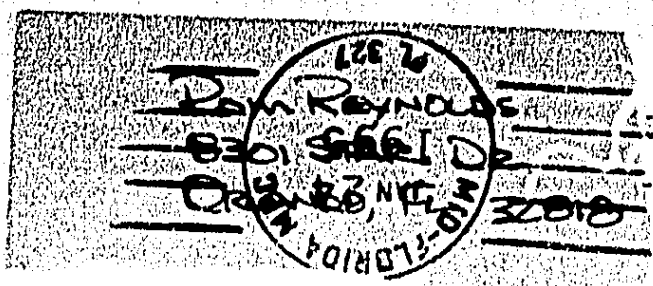

We, the undersigned, the subscribers to these Articles of Incorporation, being persons of legal age, do hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation is PAM'S PLANTS INCORPORATED

ARTICLE II

The duration of this corporation shall be perpetual, and the date and time of the commencement of the corporate existence shall be the time of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III.

The purposes of this corporation shall be any and all lawful business purposes as set forth by Florida Statutes.

ARTICLE IV

The capital stock of the corporation shall consist of 1,000 shares of common stock with a \$1.00 per share par value, all shares to have equal rights.

ARTICLE VI


