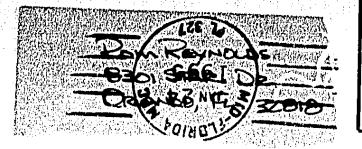

ARTICLES OF INCORPORATION

OF

We, the undersigned, the subscribers to these Articles of Incorporation, being persons of legal age, do hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following Articles of Incorporation.

ARTICLE I

The duration of this corporation shall be perpetual, and the date and time of the commencement of the corporate existence shall be the time of the filing of the Articles of Incorporation by the Department of State.
