The undersigned for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is:
JLM ENTERPRISES OF PINELLAS, INC.
The location address and mailing address of the corporation shall be 430 W. Druid Road, Clearwater, Florida 34616, which is the same as that of the registered agent.

ARTICLE II. DURATION

The term of existence of the corporation is perpetual.


