ARTICLES OF INCORPORATION OF GULF COAST HOLIDAY OF NAPLES, INC.

The undersigned hereby adopt the following Articles of the Incorporation for the purpose of forming a corporation under they laws of the State of Florida:

ARTICLE I - Name
